1. Completed application with signature due by March 30, 2012.
2. Checks for \$675.00 plus a \$60.00 electrical fee made payable to the GumTree Festival. Please send two separate checks. Amount of checks will be refunded if application is not accepted.
3. Photo of your concession tent, booth, or trailer.
4. Self-addressed, stamped envelope to acknowledge you application.
5. We will limit food vendors to six. You are not limited to what you can sell as far as food items.

Acceptance notification will be mailed by 04/06/12

1. Food vendors will be located along the curb of Court and Spring Street. Streets will be blocked to vehicular traffic on Friday, Saturday and Sunday during the festival. Artists will have access to these streets to unload from noon Friday until 9:00 a.m. Saturday.
2. Vendor spaces will be pre-assigned. For those who want to set up Friday, we will have personnel on the grounds from noon until 7:00 p.m. to guide you to your space. Your fee entitles you to operate from 6:00 a.m. until 6:00 p.m. on Saturday and Sunday.
3. Each food vending space will be no more than 25 ft wide along the curb of the street and 8 to 10 ft as available. All food spaces will be \$675.00. Multiple spaces may be requested at the time of application. Total rental fee for all spaces must be paid at time of application. Submit you electrical requirements, generators will not be allowed.
4. There will be no refund of application fees after accepted.
5. Vendors will be selected based on the uniqueness of their food items, the attractiveness of their presentation and the price of food items. Our goal is to offer a wide menu of food items at reasonable prices.
6. The festival will provide tables and chairs through the area for your customers. The city will provide small curbside dumpsters for your waste.
7. Refunds will be mailed by April 6th, 2012 to vendors who are not selected to participate.
8. All soft drinks will be sold to each vendor exclusively. Frosties, slushes, and fresh lemonade excluded. Water will be sold to each vendor by the GumTree Museum of Art exclusively.
9. The Festival is still located in the around the courthouse square. Locations of vendors and activities have been relocated. I am working on this to ensure each of you will have a great location for sales.
